Date: 19th April 2025



	- Highlighting and appreciating the role of IQAC in identifying gaps in both
	academic and infrastructural areas and in proposing effective strategies to address
	them, he recommended that these contributions be clearly documented and
	reflected in official records, such as relevant circulars and notifications, to ensure
	transparency and recognition of the IQAC's efforts.

- Collecting feedback on a quarterly or half-yearly basis, rather than on a monthly or annual schedule
- IQAC should establish a mechanism to monitor the impact of alumni engagement in various aspects of academics.
- Inclusion of a discussion on the University's best practices and institutional distinctiveness in the next meeting
- Mr. Jaimin Shah emphasized the need for skill-based training for faculty members. In response, Dr. Falguni Acharya explained that the Academic Directors are actively identifying teachers' training needs, and CHRD is providing specialized training programs to address them.
- Ms. Nilima Acharya suggested obtaining feedback from the industry after the completion of internships to assess the students' sincerity and commitment towards the internship programs.
- Dr. Amit Ganatra, Provost of Parul University, commended the accomplishments and dedication of the IQAC. He reflected on IQAC's journey, noting that it has established an effective system for data collection along with clear benchmarks for quality and excellence. He emphasized that the role of IQAC has evolved beyond Quality Assurance to encompass Total Quality Management.
